

2008 19 & Over Reining Futurity Nomination Form

October 2008 • Iowa State Fairgrounds • Des Moines, Iowa

This futurity shall be independent of any other 19 & Over Futurity classes.

Eligibility: All 3-, 4- and 5-year-old POAs will be eligible, as based upon 19 & Over Futurity rules, except they may be shown as a 3-year-old and then again as a 4-year-old. The pony shall not have been shown by an 18 & Under rider. Riders must be 19 & Over and current members of the International POAC. Riders may not show more than three ponies.

Format: *Two go rounds (preferably on separate days or one early AM and one PM).

*All entries must be drawn for position and must run as drawn.

*If a rider rides more than one pony, there should be a spread of at least two ponies between his runs if possible. No rider substitution after the first go except in the case of injury (must be approved by show management).

*Must have at least five entries or futurity will be cancelled.

Patterns: POAC patterns 6, 7, 8, 9 which are from NRHA rule book, shall be used.

Judging: *There must be two or three judges with all scores added.

*All runs must be scored.

*25 percent of purse paid in each go round; 50 percent of purse paid on composite score.

*First place ties will be worked off using same pattern and order of go. No more than one run off. If still tied, co-champs with money being split and coin toss determining winner of awards.

*Combined scores of all go rounds will determine the winner.

Payback: All fees jackpotted except judges and trophy expenses. Schedule - 40%, 30%, 20%, 10% with 25% to each go round, 50% to composite score. Attempts should be made to receive additional monies through donations, sponsorship. Trophy belt buckle award to first place composite winner. Monies will be mailed from the National POA Office.

All fees not postmarked by the due date (see payment schedule below) are tripled. Payments must be postmarked on or before the deadlines. Metered postage not accepted as proof of mailing date.
