Will consist of three classes: fillies, colts and geldings. Need not have been nominated to nor participated in Select Sire Futurity.

**Payback: 20% • 17% • 15% • 13% • 11% • 9% • 6% • 4% • 3% • 2% after all expenses.**

If a Futurity class does not have full entries to place ten winners, the vacant prize money will be divided equally by the number of winners placed in that class.
