INSTRUCTIONS:

1. Keep a separate record-sheet for each breeding season on each stallion used for breeding purposes.
2. Report shall be on file in the office of the Pony of the Americans Club, Inc., not later than Dec. 31 of each year.
3. Demand to see the registration certificate of each mare bred. This will assist you in the preparation of this report. If the owner of the mare is not the same, indicate upon this report. If mare not registered, she will need to be, prior to foal's registration.
4. Be sure the last recorded owner of the mare is the person who contracts the breeding to this stallion. If the registration papers show someone else as the owner, have them update their papers to show current owner.

5. Give exact date(s) bred -- If more than one service is given to same mare, be sure to show the different dates.
6. If pasture bred -- give date the mare was turned into the pasture and date she was taken out of pasture.
7. If this report is for a registered POA stallion, list all mares registered, or CPP identified that were exposed to the stallion.
8. If the stallion is registered other than POA, it is necessary to only list registered POA mares.
9. List mares exposed -- regardless of whether determined in foal or not.
10. White copy -- send to POAC National Office: Keep yellow copy for your records.
